**EXHIBIT FEE:** Make all checks payable to the Logan County Art League and include it with your application. Your fees will be refunded if you do not pass the jury process, after deducting a \$10 jury processing fee.

**SECURITY/INSURANCE:** Security will be on duty on Friday and Saturday night. The LCAL is not responsible for insuring exhibitors' work or displays and cannot accept responsibility for theft or damage.

**REFUNDS:** The LCAL is not required to make refunds once you have been accepted into the show.

**APPLICATION PROCESS:** We require all artists who have not displayed at Art on the Beach during the last year to submit 4 photos representative of your body of work along with your application and fee. All photos must be labeled on back with your name. When displayed, your work must be representative in quality, subject and style of your submitted photos. If you have shown work before, but have changed media or style, we ask that you send photos that document your change.

DATES: Saturday and Sunday,  
June 22 & 23, 2019

TIME: 10: 00 AM to 5:00 PM Saturday,  
and 11 AM to 4:00 PM Sunday

SET-UP: After 3 PM on Friday, 6/21/19  
or Saturday 6/22/18 7:00 AM. Please  
drive carefully to your space, being  
mindful of others. Parking is free and is  
in the lot at the park. All vehicles must  
unload and vacate the exhibit space by  
9 AM.

TEAR DOWN: Must not begin prior to  
4:00 PM on Sunday and must be  
completed by 7:00 PM .

ELIGIBILITY: NO dealers, stores or  
agents may participate. The LCAL has  
a ZERO tolerance policy for buy/sell,  
mass produced items, commercial  
molds, kits, or manufactured work.

VENDOR'S LICENSE: The State of  
Ohio requires a sales tax be paid by the  
vendor for goods that are sold within  
the state, and may visit our show to  
check for vendor's license numbers.  
Please bring your Vendor's License to  
the show.

SPACES: Each exhibitor space is  
10'x20', except spaces in the  
Community Tent which are 10 X 10  
spaces. Tents are recommended.  
Spaces are assigned by the committee  
and locations will be assigned on the  
first morning of the show.
