Copies will be sold for \$25 each and the Artist will receive \$15 per sale. Works referencing Fairborn Past or Present, USA Independence, Military Service, Community Festivals, Local Architecture, Aviation & Space Exploration are preferred.

Artists will be notified if selected, and require a one-time print processing fee of \$10 per artwork. Participation is optional. See the CONSENT FORM below.
